“Steel cages shall be inserted securely in the pier, in position and alignment, prior to concrete placement.”

2. Specifications, Page 1 of 169, Description of Work. Change the 4th line of the paragraph to:

“..piers, close coordination with the Railroad, and channel construction. All track work will be..”
